



VBS March Mystery Games Competition Terms & Conditions

4 GUESSING GAME +Final LUCKY DRAWS

1. These terms and condition shall apply to all Value Baking Supplies; 4 Guessing Games + Final Lucky Draw competition; from here on referred to as the March Mystery Games.
2. There are two parts to this competition; Part one comprises of 4 guessing games with 4lucky draws and Part two comprises of one final Lucky Draw.
3. The game is to be played on social media platform, Facebook: www.facebook.com/ValueBakingSupplies
4. Each entry must be completed in full according to the below mentioned conditions (part 1 and 2) in order to be deemed a entry.
5. Only correct entries will be submitted. (correct entries may comprise of derivatives, similar or close enough answers at the deaccession of Value Baking Supplies)
 - 5.1 **Part 1;** The 4 guessing games will commence on the following dates;
Game 1: 6 March 2023, Game 2: 13 March 2023, Game 3: 20 March 2023, Game 4: 27 March 2023,
 - 5.2 All game guessing time will close at 18:00 on the Thursday following to the game date.
Game 1 guessing Closes: 9 March 2023, Game 2: 16 March 2023, Game 3: 23 March 2023, Game 4: 30 March 2023,
 - 5.3 Terms of guessing game to be stipulated on each game post.
 - 5.4 Each player who guesses the correct answer according to points 5 permeameters & before the closing time for entries will be put into a Lucky draw.
 - 5.5 Contestants can enter as many times as they like; however only correct answers will be entered into Lucky draws. One entry per person per game will be allowed.
 - 5.6 Each correct entry per each game will qualify as a single entry into the lucky draw; entitling a entrant a maximum of 4 entries per person for the final draw.
 - 5.7 The correct answer per game set will be reveal the following Friday on Facebook along with the winners of said game.
 - 5.7.1 Lucky draw winners for the VBS R200 Vouchers will be announced on Fridays: 10 March 2023, Game 2: 17 March 2023, Game 3: 24 March 2023, Game 4: 31 March 2023
 - 5.7.2 There is one winner per week during the month of march of a vbs voucher worth R200 each.
6. **Part 2;** The Final Lucky draw will commence on 3 April 2023 following the set parameters specified below.
 - 6.1 Entries into the Lucky Draw must follow the following grounds to qualify:
 - 6.1.1 Play at least one or all four guessing games and guess the answer correctly.
 - 6.1.2 Each correct guess set out in part (5.) will count as one entry into the lucky





draw.

6.2 The Winners of the final Lucky draw event will be announced on the Facebook page on 5 April 2023.

6.3 There are 4 winners in the final Lucky draw.

6.3.1 First place winner: Lancewood Hamper worth R1000, Second Place winner: 1x R700 VBS voucher, Third place winner: Puratos Hamper worth R600, Forth Place winner: 1x R500 VBS Voucher.

6.4 Price collections will be arranged with each winner privately.

6.5 Winner will have to provide contact information as required for verification purposes.

6.5.1 The winners of the hampers; will either have to collect their hampers instore at Value Baking Supplies Brackenfell or can arrange to have the hamper couriered to them at their own cost.

6.5.2 The winners of the vouchers; can either collect their voucher instore at Value Baking Supplies Brackenfell or have it emailed to them.
